## 2020: A Year Like No Other

#### NJUA Convenes Members and Submits Comments for BPU COVID Proceeding

On November 30, NJUA filed joint comments on behalf of its member companies in response to the Board of Public Utilities's October 28th Order establishing a proceeding to seek stakeholder comment on the timing, scope, and issues to be addressed relative to the COVID 19 pandemic. The NJUA comments reflected the Association's support for continued investment in utility infrastructure and development of programs and mechanisms aimed at helping customers in need.

#### NJUA Coordinates Members of the Restart and Recovery Advisory Council

In June, after coordinating discussions amongst NJUA Members serving on the Governor's Restart and Recovery Advisory Council, NJUA stressed the Utilities' intention to assist the State in its economic recovery efforts through utility infrastructure projects directly to the Council Co-Chairs. With utility Members' support, NJUA shared a list of project categories with the Council that would spur economic activity and create jobs as well as modernize, enhance and address risk mitigation to create safer, more reliable, efficient, and environmentally responsible infrastructure. Soon after, NJUA followed up with the Co-Chairs of the Restart and Recovery Advisory Council, reiterating the need for necessary recovery mechanisms and timely regulatory reviews by the applicable government entities in order for the Utilities to invest billions of dollars that would create thousands of jobs across the economy over the next five years.

#### NJUA Leads Discussions with BPU and Governor's Office on Shutoff Moratoriums and Payment Assistance; Executive Order 190

During the summer of 2020, NJUA proudly served as the liaison between the utilities' regulatory authority, policymakers, and member companies on discussions around shutoff moratoriums and payment assistance. After months of discussions, Governor Murphy announced in late August that New Jersey's investor-owned electric, natural gas, and water companies voluntarily extended shutoff moratoriums through October 15. The Governor's announcement also noted that companies are offering enhanced Deferred Payment Arrangements for 12 to 24 months. In October, Governor Murphy, through Executive Order 190, extended the utility shutoff moratorium, preventing New Jersey residents from having their utilities disconnected through at least March 15, 2021.

Prior to the issuance of EO190, NJUA spoke with key policymakers about the Executive Order. Subsequently, BPU President Joe Fiordaliso and Lieutenant Governor Sheila Oliver co-authored an <u>op-ed</u> encouraging customers to reach out to their utilities to seek assistance that is available. NJUA also authored an <u>op-ed</u> and worked with the BPU's communications team to coordinate company messaging around the moratorium and payment assistance.

#### NJUA Works For Permit Extensions During COVID-19 Emergency

Once the COVID-19 crisis began emerging, NJUA worked diligently for passage of S2346/A3919, the Permit Extension Act of 2020 (PEA). As the bill moved through the legislative process, NJUA worked with policymakers on this legislation to assist those whose projects may be held in abeyance as a result of the COVID-19 pandemic. Many of these projects have already received myriad governmental permits and approvals, which are expensive and time-consuming to obtain.

In July, Governor Murphy signed this Act into law. The PEA extends certain governmental permits, approvals, and deadlines for the duration of the "COVID-19 Extension Period." The Extension Period began on March 9, 2020 and continues until the end of the COVID-19 public health emergency. The PEA also provides an additional six months of tolling.

## What We Are Keeping An Eye On

As always, in 2021 NJUA will advocate for implementation of sound utility policy and coordinate sharing of best practices on numerous issues through our standing committees. Looking ahead, these are some of the issues we are most excited to work with our Members on:



Promoting **stimulus projects** that will help **bolster economic recovery** through the creation of thousands of jobs and improvements to our energy, water, and wastewater infrastructure.



**Essential utility workforce safety measures** in response to the ongoing COVID-19 pandemic. This includes priority vaccination efforts along with sharing of best practices on continued application of PPE and workplace safety protocols developed through NJUA's Preparedness Workgroup in 2020.



Advocating for **innovative regulatory mechanisms** to address challenges related to the COVID-19 pandemic and assisting customers in need.
